Safety Officer Presumptions

*LC 3761, 5402: Effective 1/1/2023, if liability for claim of injury described in section 3212-3212.85 and 3212.87-3213.2 is not rejected within 75 (from 90) days after the date the claim form is filed pursuant to Section 5401, the injury shall be presumed compensable

*LC 5414.3: Effective 1/1/2023, the penalty for the unreasonable rejection of claims made under sections 3212-3213.2 is 5x the amount of the benefit up to \$50,000.00 (from \$10,000.00)

*LC 4656: Aggregate TD payments for a single injury or condition described in section 3212.1 (cancer) occurring on or after 1/1/23 shall not extend more than 240 (from 104) compensable weeks
